- Event Wagering (EW) Operator An owner or operator of an Arizona professional sports team or franchise, an operator of a sports facility in the state that hosts an annual tournament on the PGA tour or a promoter of a national association for stock car auto racing national touring race in this state.
- Event Wagering Operator (Tribal) An Arizona Indian Tribe or an entity fully owned by an Arizona Indian Tribe.
- **Designee (EW)** a person authorized to act on behalf of an event wagering operator and who is responsible for the management and control of event wagering operations. A designee is not independently eligible to become an event wagering operator, nor is it eligible to transfer licensure.
- Fantasy Contest (FS) Operator A person that is engaged in the business of professionally conducting paid fantasy sports contests for cash or other prizes or awards for members of the general public that requires cash or cash equivalent as an entry fee to be paid by a member of the general public who participates in a paid fantasy sports contest.
- Management Company (FS) A person/entity retained by a fantasy sports contest operator to manage a fantasy sports contest platform and provide general administration and other operational services.
- Holding Company (FS) A corporation, firm, partnership, limited partnership, limited liability compact, trust or other form of business organization that is not an individual and that directly or indirectly does either of the following:
- Management Service Provider A person that operates, manages or controls event wagering authorized by this chapter on behalf of an event wagering operator or limited event wagering operator, including developing or operating event wagering platforms and providing odds, lines and global risk management, and may provide services to more than one licensed event wagering operator or licensed limited event wagering operator.

- Holds an ownership interest of ten percent or more, as determined by the holding company's board, in a fantasy contest operator.
- Holds voting rights with the power to vote ten percent or more of the outstanding voting right of a fantasy sports contest operator.
- Supplier A person that does not meet the criteria of "Ancillary Supplier," and manufactures, distributes or supplies event watering equipment or software, including event wagering systems.
- Ancillary Supplier includes persons who satisfy the definition of supplier in the Act and persons who provide goods and/or services, directly or indirectly, to a responsible party in connection with event wagering pursuant to the Act. Ancillary suppliers include:
 - Affiliates;
 - Bookmakers;
 - Data centers providing physical security and infrastructure;
 - Geofence providers;
 - Identity verification service providers;
 - Independent test laboratories;
 - Integrity monitoring providers;
 - League data providers;
 - Marketing affiliates;
 - Payment processors; and
 - Any other person as determined by the Department.
- Limited Event Wagering Operator A racetrack enclosure or additional wagering facility (OTB) that holds a permit issued by the Division of Racing to offer wagers on horse racing and that is licensed under this chapter.
