### Recently Appointed Commissioner Dr. Ara Feinstein Welcomed to Arizona Boxing & Mixed Martial Arts Commission

PHOENIX – Today, the Boxing & Mixed Martial Arts Commission welcomes new Commissioner Ara Feinstein, M.D., who was appointed by Governor Doug Ducey to serve commencing January 18, 2021. Dr. Ara Feinstein has over a decade of experience as a trauma surgeon and ringside physician. He currently serves as an associate professor at the University of Arizona College of Medicine-Phoenix and Physician Executive at Banner Health. Dr. Feinstein’s dedication in academic, administrative and professional medical roles furthers the Commission’s commitment to supporting the health and safety of athletes.
