## Arizona Racing Commission approves temporary permit for Rillito Park in Tucson

Nov. 6, 2014—The Arizona Racing Commission gave temporary approval for a permit to conduct a 20-day live racing meet at historic Rillito Park in Tucson beginning in February of 2015.

The decision by the Commission during a special telephonic meeting held Oct. 21, allows for management of Rillito Racing Inc. to begin preparations for live racing at the Tucson facility, while its Commercial racetrack application is under Substantive review. The temporary permit remains in effect until such time as the permit review process is complete and the Commission has made its final decision.

In July of 2014, the Pima County Board of Supervisors awarded a lease of the racetrack facility to the Rillito Racing, Inc., a subsidiary of the non-profit Rillito Park Racing Foundation. The group won the competitive bid against the Pima County Horsemen's Association, which conducted the race meet for more than 25 years.

The proposed 20-day meet calls for racing on Saturdays and Sundays from Feb. 7 through April 11. In addition, two special Friday cards are planned for March 27 and April 10. On Easter Sunday no racing will be conducted.

The proposed schedule is as follows:
