Concerns Voiced Within the Racing Industry Pre-Pandemic

- Industry-wide struggle to connect with new fans and increased indirect competition¹
 - Customers over age 56 make up 45% of the demographic market²
 - Younger consumers are less drawn to the sport
 - There are concerns relating to environmental impact, animal treatment, and other social issues
 - Negative industry publicity also has drawn them away from the sport, regardless of whether these concerns are accurate³
 - Greater indirect competition with other leisure activities such as football, basketball, baseball, hockey, etc.⁴
 - In 1985 horseracing was the 8th most popular sport and 4% of Americans listed it as their favorite sport, compared to 2016 where horseracing was the 13th most popular sport and 1% of Americans listed it as their favorite sport⁵


- Members of the racing community called for industry-wide change to "reconnect with old fans, cultivate interest with millennials and resurrect the game."⁶
 - The marketing efforts of various tracks support this⁷
 - Promotional T-shirts, caps, and drinks targeting a younger demographic⁸
 - Pony rides for children⁹
 - Social Media promotion¹⁰
 - Date Nights, drink specials, celebrity appearances, and concerts¹¹



The Racing Industry Internationally: The United Kingdom

- In the UK horseracing is the 2nd largest sport, yet it faces similar struggles as the U.S. with regard to attendance, popularity, and the need to attract a younger demographic: 12
 - UK attendance dipped below 5 million for the first time in 25 years¹³
 - Tracks engaged in new marketing strategies such as free admission to patrons who publicly shared their passions for racing and hosted events for children to teach them about the racing industry¹⁴
 - The British Horseracing Authority faces similar challenges and protests from animal rights groups as well as the public perceptions of racing¹⁵
 - Tracks are also struggling with lower prize money, which impacts the industry's ability to compete with international markets¹⁶

The Racing Industry Internationally: Australia

- Racing is an important contributor to the Australian economy, and per capita "Australia has arguably the strongest racing industry in the world."¹⁷
- Australia faces struggles, among which animal welfare and money laundering are currently the most pressing¹⁸
 - Starting in 2019, there was a large public outcry calling for better protections for racehorses, particularly those that are injured, retired, or unsuccessful¹⁹
 - Current legislation in Australia is insufficient to protect against money laundering, notably transactions for shares of horses do not have to follow 'know your customer' requirements or report transactions over \$10,000²⁰



The Racing Industry Nationally

- 2023 Horse Racing Tracks Industry Statistics²¹:
 - Market size by revenue: \$4.9bn²²
 - Growth rate 2023: -1.9%²³
 - Growth rate 2018-2023: -5.2%²⁴
- US gambling and Horse Racing industries have faced stagnation and decline in recent years due to consumers' low disposable income, changing consumer preferences, and competition from other forms of entertainment²⁵
 - As a result, many tracks and gambling facilities have merged with other entities leading to industry concentration and fewer choices for consumers and workers²⁶




Graph Depicts Inflation Adjusted Personal Consumption Expenditures on Gambling from 1978-2022



The Impact of Electronic Wagering

- Traditional betting methods have shifted to digital platforms resulting in changes in revenue streams, market dynamics, and changes in consumer behavior²⁷
- Since the legalization of electronic wagering consumers can now place bets on sports like football and basketball, both sports are indirect competitors of racing and share a similar fan base of older men with greater disposable income and leisure time²⁸
 - New wagering opportunities in these sports have increased competition
- While electronic wagering on sports like football and basketball expands, some predict that rather than attracting new players it will cannibalize existing markets including racing²⁹




Graph depicts severe dip in Nevada's sports gambling revenues starting in 2018 when sports betting became possible in other jurisdictions



The Horseracing Integrity and Safety Act

- HISA was created is response to the 2019 racing season, in which 441 thoroughbred racehorses suffered fatal injuries—the U.S. fatality rate being 2.5 to 5 times greater per race start than Europe and Asia—and concern over jockey deaths and injuries³⁰
 - HISA's authors sought to address issues related to track surface, training, drug use, and drug testing, and to create uniform rules throughout the country rather than the previous patchwork of regulation³¹
 - The House Committee Report highlighted major differences in drug testing compared to other nations and the struggle to unify testing procedures among various states³²





The Racing Industry in Arizona

- Racing in Arizona has historically had an impact that extends beyond the tax-revenues of pari mutuel racing and revenues generated directly by the tracks³³
 - There are economic spillover effects into other adjacent equine industries like breeding, grooming, veterinary care, alfalfa farming, etc, that have some dependence on racing in Arizona³⁴
- For example, a 2016 economic study found that Turf Paradise contributed an annual economic impact of \$91mil to the state of Arizona and that every \$1 injected into the racing industry had an economic impact of \$2 on the Arizona economy³⁵
 - However, it is unclear how/if that has changed today with numerous articles questioning the economic viability of Arizona's tracks³⁶
 - Regardless, it is important to note the historical and financial significance of racing to develop novel solutions to solve the industry's challenges.³⁷
