The maximum number of Class III gaming devices currently allowed in Arizona is 18,158.

The 18,158 maximum includes transfer agreements (slot machine rights tribes can lease or sell to other tribes).

Column (1) represents the tribe's old maximum gaming device allocation in 2003. **This column is no longer valid.**

Column (2) represents the current maximum number of gaming devices for the tribe, excluding any gaming devices the tribe can obtain through Transfer Agreements.

Column (3) represents the maximum number of additional gaming devices a Tribe can obtain through Transfer Agreements.

Column (2)+(3) represents the current maximum number of gaming device operating rights for the tribe, including those devices the tribe can obtain through Transfer Agreements.

(a) Based on Population Adjustment Rate of 1.19. Tribes get an automatic increase every five years in the maximum number of Class III gaming device allocations and card tables proportionate to the increase in the Arizona state population. The maximum number of gaming devices and card tables allowed for each tribe was adjusted accordingly in 2008.

(b) From column 2 "Additional Gaming Devices" as listed in **Compact Section 3(c)(5)** Gaming Device Allocation Table

"...except if the Tribe is Salt River Pima-Maricopa Indian Community, Gila River Indian Community, Pascua Yaqui Tribe, Tohono O'odham Nation, or Navajo Nation, then the Maximum Devices Per Gaming Facility is the same number as the Maximum Devices Per Gaming Facility for Ak-Chin Indian Community and Ft. McDowell Yavapai Nation. ..."

"...If the Tribe is the Tohono O'odham Nation, and if the Tribe operates four (4) Gaming Facilities, then at least one of the four (4) Gaming Facilities shall: a) be at least fifty (50) miles from the existing Gaming Facilities of the Tribe in the Tucson metropolitan area as of the Effective Date; b) have no more than six hundred forty-five (645) Gaming Devices; and c) have no more than seventy-five (75) Card Game Tables."
